- Certified Director: Combined scores of at least 66 points in all ten skill areas, with a minimum of 7 points in the area of directing skills, a combined minimum score in the five remaining musical/technical areas of at least 33 points and a minimum of 6 points in each area, and at least 26 points in management/communications skills with a minimum of 4 points in each area; must have attended a regional or international educational event during the past 12 months; and must be currently serving as director/co-director or associate/assistant director of a chartered Sweet Adelines International chorus
- Harmony 500 Director: Must have achieved the level of Certified Director and then a minimum of 500 points in a regional chorus competition, and must have been the chorus' director for at least one year
- Master Director: Must have achieved the level of Certified Director and then a minimum of 600 points in a regional chorus competition or 1200 points in an international chorus competition, and must have been the chorus' director for at least one year
- Master 700 Director: Must have achieved the level of Master Director and then a minimum of 700 points in a regional chorus competition or 1400 points in an international chorus competition, and must have been the chorus' director for at least one year
