Hi Becky,

Thanks for responding. The only "road map" I know of to get you through the DCP is the DCP Modules that are available through International. Module 1 and part of module 10 can be completed by a regional music staff person. If you have had a coach from the region that is familiar with your conducting and rehearsal planning, they can fill out the evaluation. Let me know who that person could be and I will ask Lynn Hartmuth is it's okay. As Education Coordinator, she needs to approve the evaluation. Modules 4, part of 5 and part of 8 involve a questionnaire completed by 12 members of your team and chorus. These are the easiest to get completed. Members will rate you on a scale of 1-5 for you teaching, managing and communicating styles. Let me know if you are ready for me to send the questionnaires to your team manager.

The modules that include tests can be taken as many times as you like and I will use the best score. I think you will find they are not that bad. I thought the vocal production one was pretty difficult because it involved a lot of medical questions about the throat and breathing apparatus. Music theory might be difficult if your not real

familiar with reading music or chord structure.

All I did was read through the modules right before a testing time and took my chances. You can complete any one or all of the modules you want at one time. You do not need to test on all the modules at once. However, I do need to be present when your taking the tests.

So maybe we can plan to do some testing at the planned Director's Seminar later this fall. It's in the directory for either September 21 or 28. Maybe we'll hear something soon.
