Welcome and Agenda Review

Sue welcomed all to the Zoom meeting – All were in attendance.

SAI BOARD MEMBER THERESE ANTONINI - Therese joined our RMT meeting to provide an International Update and answer any questions we had.

Therese will report back to SAI the Region RMT's thanks for the \$400 stipend and that monthly communication is appreciated.

New Song Assessment Kit – This is available now and sent to Directors. It is located on the website under Chorus Education Tools. Contest songs are being evaluated first then other songs as time permits. There are approximately 50 songs on the list currently and growing. There are several teams working on evaluations and rating strictly on the Racial component. Spiritual songs will be let to the Chorus discretion. Marsha mentioned the medley that POK was planning to use at contest will not be done now due to racial component they were unaware of.

Region Contests – Target date for decision on 2021 has not been set but hoping to have soon. SAI is being hopefully cautious and want to have something – do not want to go 2 years without some type of meeting.

Diversity/Inclusion SAI Committee will have a big announcement in September so watch for the email.

Char Gurney IES Scholarship - \$2000. This would be an all-expense paid trip to the 2022 IES /Director training for a Region 4 Front Line director. Discussion on if we would participate with the SAI Scholarship or established for just Region 4 members. Sue is going to get clarification from SAI on their program they are creating and then we will move forward. RMT feels it needs to stay within Region 4 if we are fund raising. Committee will need to be set up to coordinate this scholarship program/guidelines to share with the members.

Leadership Workshop Feedback – Survey results have been shared with RMT. Videos will be up soon. For the 1st time in this format it was good and region members glad RMT stepped up and did something. It did seem to be "safe". Need to ensure all members are aware this is open to anyone and not just leaders. Possibly renaming it but keep "Lead" in the title so attendees will know what the primary directive is.
