## • <u>Soar with Four – Leadership Development Program:</u>

- The first in-person training was conducted at Singing Summit and was very successful. All class participants were in attendance.
- Vicki Petzko conducted the training. She didn't quite get finished with her presentations, but all info has been logged into our special file on the HH4 website.
- Sue met with the Soar with Four committee during Singing Summit to discuss the future the of program, as well as our next in-person class during the Express Yourself event in June.

- The committee discussed the need to get participant testimonials in preparation for the 2026 class.
- The Soar with 4 Leadership Team agreed to continue through the 2026 course.
